Instructions for Fee Payment

The candidates provisionally selected for admission to the Second Year (III Semester) of the M.A. in Corporate Communication & Brand Management (MA-CCBM) and M.A. in New Media Communications (MA-NMC) programmes at different regional campuses of the Indian Institute of Mass Communication (IIMC) for the Academic Session 2026–27 are required to pay the Third Semester admission fee of ₹79,000 (Rupees Seventy-Nine Thousand only) for MA-CCBM and ₹94,000 (Rupees Ninety-Four Thousand only) for MA-NMC on or before 28 July 2026 to confirm their admission.

Failure to deposit the prescribed fee by the stipulated date may result in cancellation of the admission offer, and the seat may be allotted to the next eligible candidate.

Hostel and Mess Fees

Hostel accommodation is subject to availability. Hostel fees shall be charged separately on a semester basis and must be paid at the time of hostel admission. Mess charges shall also be payable separately. Detailed instructions regarding hostel allotment and fee payment will be notified separately.
