The vendor shall supply potable water to the IIMC Aizawl Campus through water tankers and supply is to be executed strictly on demand as communicated by the Institute's authorized representative.

3. Terms & Conditions

The vendor shall ensure the following without fail:

- Tankers must supply clean, potable water fit for general domestic and institutional usage.
- The vehicle and tanker deployed shall maintain valid documentation (RC, insurance, fitness, pollution certificate, and driver's licence).
- All deliveries must be logged, acknowledged, and invoiced as per institutional protocol.

Performance Standards

Consistent, timely, and uninterrupted service is non-negotiable. Any deviation, lapse, or non-performance will trigger corrective action—up to and including termination of this work order. The Institute expects operational discipline and service reliability without exception.
